
Buildings of Character Lingfield Neighbourhood Plan Report

Within the parish area of Lingfield, there are 49 Heritage Assets Listed with Historic England, two of which are the highest listing, Grade I, one Scheduled Ancient Monument and 19 hectares contained within a Conservation Area. The village identifies as a "Historic" village because of the number and variety of Heritage Assets within its area, most of which are clustered around the Old Town and Church and Plaistow Street.

Tandridge District Council has a list of Locally Listed non-designated Heritage Assets, referred to currently and "Buildings of Character"¹ which was compiled in 2013. The current NPPF (2021) indicates development affecting their significance or that could cause them harm will need closer assessment of the potential impacts.

The first listed objective of the LNP is to "Retain the village atmosphere, appearance, and setting", and to achieve this the LNP suggests the inclusion of additional buildings to the non-designated heritage asset list, which have been identified as being key buildings within the Conservation Area, that are not offered sufficient protection from development as listed buildings are, and to include buildings which are part of the history of the village and form an integral part of what gives it its character. This is included within LNP Policy CHP4.

Policy CHP4 - Managing Development of Heritage Assets

1. Alterations and extensions to all Heritage Assets should respect the character of the adjoining buildings and the wider area and this can include good modern design which is well integrated.

2. The Neighbourhood Plan has identified a number of buildings which it considers should be listed as Non-Designated Heritage Assets (Tandridge Buildings of Character) to be submitted for adoption by Tandridge

There is one building in the Tandridge List, Kingsley Farm Barn, which was demolished without permission in the 1990's. The Old House, Godstone Road is a Listed Building and wrongly included. With the additional proposals from the LNP, Tandridge can update their list.

Tandridge uses a set of criteria to identify and include additional buildings onto the list. Surrey County Council are also updating the historic record of non-designated heritage assets, and the criterion they are using for identification is listed fully in the appendix to this document along with that of Tandridge Council. They have been used by the LNP to justify inclusion of the new proposals. Detailed applications will be produced to submit to TDC/Surrey County Council

A	Rarity	A rare survival of an asset type, either due to its intrinsic rarity or through its integrity, i.e. it is largely unaltered. The age of an asset will be a factor to be taken into consideration under this criterion. Rarity will also be considered in a local context, i.e. an asset may have greater significance in one place than in another.	Although age is not a criterion itself, the older an asset is the rarer and more significant in heritage terms it is likely to be. Rarity has a geographical dimension. Context and location will be important as survival and significance vary considerably depending on what an asset is, and where it is located. Rarity may relate to the survival of fragile features such as prehistoric field systems and hollow ways.
в	Group Value	Strong functional or visual link with other assets, the asset contributing to the understanding of asset groups or complexes which have significance or prominence in a local context.
