## **Lingfield Neighbourhood Plan Report**

This report lists key community Assets identified by residents through public engagement and by the Steering Group. These Assets meet the requirements of the Community Right to Bid, Localism Act (2011) and the Assets of Community Value (England) Regulations (2012)

The Lingfield Neighbourhood Plan recommends that Lingfield Parish Council apply for the designation of the following Assets to Tandridge Council, and as these will need to be renewed every three years, to plan to review them periodically to ensure their place on the register remains valid.

The application forms and links to the My Community website are found on the Tandridge Council website 1.

The LNP has separated the proposed Assets into buildings and land, some of latter is also submitted to Tandridge Council for allocation as Local Green Spaces, which is a different category but not detrimental to the case for including it within this list. Local Green Space designation does not include the Community Right to bid, should the open space be put up for sale.

The following tables list the suggestions for application for consideration as Assets of Community Value<sup>2</sup>. Each application will require some further details to be provided, this list can be considered as a starting point for the community.
